By accepting the financial assistance offered to be by ENTER International for the Venetian
ESummer 2024 program, I agree to and accept responsibility for the following conditions:

1. Financial aid and Scholarships are seen as comprehensive fee waivers. No deposit will be made in my bank account as ENTER International will pay directly for the hotel facilities and other expenses to be covered.
2. Financial aid and Scholarship will not include additional meal costs or the health insurance that will be my responsibility to provide before the program and will be suggested to me by the Project Managers of ENTER International.
3. Any aid offered to me will exclusively cover what is stated in the financial aid package.
4. I will be requested to pay the entire tuition fee within 3 months from the moment that the program ends. If I do not respect the commitment and mutual responsibility pact, or infringing any regulations of the code of honor and behavior during the Venetian ESummer, additional fines and authority intervention might be applied depending on the gravity of my actions.
5. I understand that it is my responsibility to inform the Admissions Office of ENTER International in case of any transportation concerns and last-minute cancellations. The Board of Executives of ENTER International will be the ones evaluating how much reimbursement to be issued based on the non-refundable part of the hotel and tuition costs, and considering the related concerns caused in logistical terms to ENTER International's team.
6. I understand that I must make normal progress towards the completion of my summer course program, according to ENTER's perspective, as outlined in the



"Commitment and Mutual Responsibility Pact". Failure to make satisfactory progress, according to ENTER, upon what is stated in that pact may result in my being ineligible for further aid.

7. Finally, if I never attend, cease to attend, drop, or withdraw, my financial aid may be reduced or canceled, and I may be liable to repay any amount of assistance already received for the Venetian ESummer program.
8. I hereby authorize ENTER International to release information concerning my academic progress and/or financial status to any agency or donor who contributes to my financial assistance, since this information may be essential for the continuation of such assistance.
9. I understand that any violation of the regulations, as set by ENTER, governing the financial aid program is sufficient grounds for termination of my financial aid and referral for disciplinary action.
 - a. Violations include but are not limited to, falsification of any document used to obtain financial aid, using financial aid funds for non-educational purposes, and falsification of any academic or extracurricular result.

I hereby commit to paying the enrollment deposit of 50€(fifty euros) by the **7th of April 2024** and paying the remaining cost with an end date on **the 15th of May 2024** either through installments, as chosen in the Financial aid commitment form, or through a single deposit.

My spot will be then confirmed for either the In-Person or Online Version, with the possibility of electing the Online version for financial reasons or last-minute VISA issues concerns.
