1) Terms of Scholarship:

The Florentino Merit Scholarship, awarded to the Scholarship Recipient, is subject to the terms and conditions outlined herein.

- a) The Scholarship Recipient shall receive financial support for travel expenses, hotel accommodations, and tuition fees associated with the Venetian ESummer program.

2) Travel Expenses:

- a) Depending on the financial circumstances of the Scholarship Recipient, the Scholarship Provider shall cover the round-trip flight/train or bus fare.
- b) In cases where the Scholarship Recipient's financial ability is limited, the Scholarship Provider may cover only the departure expenses and promptly notify the recipient.
- c) take note that the grant is on a sponsor's discretionary basis.

3) Program Attendance:

- a) The Scholarship Recipient agrees to attend the Venetian ESummer program for the entire duration of the summer camp.
- b) If the Scholarship Recipient is unable to attend the program for the full duration, due to unforeseen occurrences, their financial aid may be reconsidered, subject to the Scholarship Provider's discretion.
 - i) Reconsideration shall be based on factors including the impact on the performance of other students and logistical arrangements.
 - ii) The responsibility doesn't lie with Enter International.

4) Expenses Coverage:

- a) The Scholarship Provider shall cover hotel and tuition expenses associated with the Venetian ESummer program.
- b) The Scholarship Recipient acknowledges that they may still bear certain costs, such as a non-refundable deposit or food expenses, as specified in the



scholarship's financial aid package as these extra costs which are outside the Scholarship Provider's budget.

- 5) Interviews and Image Usage:
 - a) The Scholarship Recipient agrees to participate in interviews conducted by the Scholarship Provider.
 - b) These interviews may be used for promotional purposes to disseminate information about the Venetian ESummer program to other students.
 - c) The Scholarship Recipient grants permission to the Scholarship Provider to use their image during and after the program to publicly identify the awarded student for the year 2024. These images will only be for educational purposes and will not be for personal gain of which Enter International will not be responsible.
- 6) Compliance and Reassessment:
 - a) The Scholarship Recipient acknowledges that failure to comply with the details stated in the Florentino Scholarship terms and conditions may result in partial or complete reassessment of their financial aid, at the Scholarship Provider's discretion.
